Breeze Report

Since there was no December Community Club meeting, I have no minutes to publish. Which means I have a bit of space to fill. So this seems like a good opportunity to file a year- end financial report for The Breeze report.

As I took over as editor of the Breeze in April of 2004, 2005 is the first full calendar year for which I have been able to keep track of expenses and revenues for the Breeze. Now bear in mind that I am not an accountant, and our club treasurer, Chuck Flaig, is likely to have more accurate figures than I, but here's what I've come up with.

The primary cost for the Breeze of course is for printing. Since I took over I have been having Shel-Don Reproductions doing this, and I have been very pleased with their work. Let me give them a plug here. They have been very efficient, friendly and easy to work with, and their downtown location makes it convenient for pick-up. Cost wise, they seem to be competitive with other local printers. The actual cost of printing each issue varies, depending on the size of the issue and if there is any extra advertising work to do, but the total cost of printing 12 issues of the Breeze, at 850 copies per issue, was **\$3,917.06**.

The only additional cost to the club is for postage. While the vast majority of the copies are distributed by our hardworking volunteer delivery people, I do mail out about 30 copies a month, mostly to public officials and organizations who we want to keep aware of our club activities, but a few go to off-Point subscribers. I also mail copies to a few of our advertisers, and of course a few stamps go for mailing out invoices. I buy the stamps in rolls of 100, and bearing in mind that I still have a few stamps left, I show my cost for the year at **\$148**.

Offsetting these expenses are our advertising revenues, and we've had a pretty good year. We were very fortunate this past year to receive a full page, full year exclusive ad from Vogel Construction. I don't know if they'll extend into the new year yet, but I do appreciate their business. And Dick at Bayside Market has been our most consistent long term advertiser. His half page ads have been a staple of the Breeze. Other full year advertisers include both Our Lady of Mercy and St. Andrews by the Lake Churches, Mark Bovee of Edina Realty, Lynden Medlin or A.G.Edwards, and Jeff McCaffrey of Twin Ports Insurance. And I have to mention the Shops on Park Point, Country by the Lake and Blue Iris Gallery, who if not full year are at least frequent advertisers. There are a number of others who took out either one month or intermittent ads, and I want to thank them all. I realize that for some businesses it's more a matter of supporting the Breeze than attracting customers, and I appreciate that. And I hope that our readers recognize that, and support their businesses as well. That said, our total income from advertising for 2005 comes to **\$2,762.00**

The only other income comes from off-Point subscribers, who pay \$10 a year to have the breeze mailed to them. Now I don't see all the subscriber's checks, and renewal dates are all over the calendar, and sometimes I miss them, but by my estimate, we should have taken in about **\$100** in subscriptions. So our accounts look something like this:

Expenses: \$4065.06
Revenues: -\$2862.00
Total cost to the club: \$1203.06

Now while the ultimate goal is to make the Breeze pay for itself, I feel we've done pretty well this year, given the income of the club, and what we get out of the Breeze. And I encourage other Park Point business owners to consider advertising in the Breeze. Rates are quite reasonable, and the goodwill is priceless.

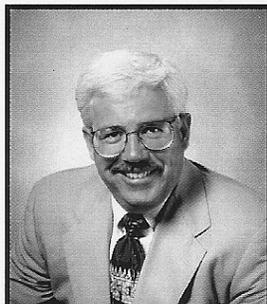
