Neighborhood Night Out

Tuesday, August 4th

National Night Out? Neighborhood Night Out? Neighbors' Night Out?

No matter what you choose to call it, this national event doesn't appear to be risking death from lack of interest. Bottom line: The emphasis is on Neighborhood. Here on Park Point, where "neighborhood" stretches for over forty blocks, there are many such gatherings up and down the Avenue each year.

In the summer of 2009, the Community Club was approached by the nascent Edible Garden Club, which invited PPCC members to join them for a National Night Out picnic at Lafayette, in order to show off their new accomplishments. "At the time," club 'historian' Lyn Clark Pegg reminded me, "we had little more than the fruit trees we had just planted, and only a few beds. We wanted to raise both awareness and funds, in order to continue a project we believed in." By the following year, there was even more to show off, including the newly-installed "turrets" leftover from a recent re-building of Bayfront Play Area and the now-traditional Summer Youth Program scarecrows, which combine to give the Edible Garden its distinctive look. Over time, the Lafayette event grew larger, and several smaller venues were consolidated into one. This year, as you'll note on page 7, St. Andrew's Episcopal Church has formally invited Park Pointers to join them for an NNO picnic and "mini-tour" of their recently remodeled sanctuary.

Another favorite hot spot has been the annual gathering at 16th street, jointly sponsored by surrounding neighbors. I well recall how welcome I felt personally, as a Park Point newbie, to be included as an honorary member of what many of us affectionately call "The Sixteenth Street Gang." PPCC Treasurer Al Robins and former Club Secretary Sheryl Robins have spoken of how much they enjoy the picnic hosted in their immediate neighborhood. Whether large or small, these gatherings - both on Park Point and throughout Duluth and the nation - present a popular way to fulfill the goals of the National Association of Town Watch, which organized the first National Neighborhood Night Out back in 1984. (The official name was shortened to National Night Out in 1992.)

The NATW is a network of law enforcement agencies, neighborhood watch groups, civic groups, state and regional crime prevention associations, and concerned citizens. While the original NNO primarily highlighted crime prevention, the event has evolved over its 32 years to focus not only on the building of police/community relationships, but also upon community-building among neighbors in the larger sense. Neighborhoods in 48 states mark the first Tuesday of August as the date to hold block parties, festivals, parades, cookouts, seminars, youth events, and visits from emergency personnel - always hoping to bring police and neighbors together under positive circumstances. Why only 48 states? Florida and Texas hold their NNO in October, to avoid the heat. Smart people!

When I was new both to Duluth and its tiny Park Point, I was often shocked when introducing myself to hear someone say, "Yeah...I know who you are..."

Working Group Report

The City Planning Department conducted the second Study Group meeting on Wednesday, May 27. At the first meeting, it had been determined that legal issues needed to be addressed before the group could begin the work of selecting Tier 2 sites. City Planners said they would ask City Attorney Gunnar Johnson to review our legal questions and report back at the next meeting. The City Attorney declined to address the Study Group, which was very disappointing. City Planner Keith Hamre responded only to the questions that John Schmidt and Chelly Townsend had sent. He gave brief answers to those questions. Other people had sent questions and the City Planners at the previous meeting took notes of questions that we asked during the first meeting. They answered only the questions John and Chelly had emailed. They would not comment on case law questions that residents had sent.

Important highlights:

City Planners confirmed that the City, in accordance with the Jewell 1990 resolution, would no longer approve full vacation requests to residents living on street ends. We asked how this could be codified. Councilor Gardner and Keith Hamre reported that they are working on additional language to the Jewell resolution that would describe in detail a plan for "neighborhood pedestrian access" to the beach and bay, and that the plan for no full vacations would be included.

The City believes that all street ends are closed unless they are "improved" in some way. This is contrary to what we had believed to be true.

The City also believes that the Jewell resolution is not considered applied legislation, even though it has been the only clear legislating document for twenty-five years.

Councilor Gardner and City Planner Keith Hamre promised that no action would be taken on street ends until Tier 1 site issues were addressed. They thought this could take up to five years. In the meantime, they want us to evaluate the sixteen street ends and have a plan for the time when additional street ends will be opened for public access.

We reminded them of the Tier 1 issues:

- Inadequate signage – visitors don't know which sites are currently designated as public access.
- Parking issues at Franklin and Lafayette, again due in part to lack of signage.
- Under-utilized beach house area, because visitors don't know how to find it.
- Inadequate garbage facilities causing debris that residents usually clean up.
- No plan for emergency medical services.
- Environmental damage due to inadequate signage and lack of oversight.

At the next two meetings, we'll review street ends.

PPCC Meeting Minutes - 6/18/15

President Dawn Buck called the meeting to order at 7:04 pm. The minutes from the May meeting were approved, with no corrections or additions.

Hospitality - Thank you to Diane Gould for providing refreshments at the meeting.

Treasurer's Report - Al Robins

1) The general fund has \$37,828; the Art Fair fund has \$30,237, including money from the Arts Commission grant and artist fees. Current total of both funds is \$68,065. This will be reduced to approx. \$38,000 after paying the fees and costs related to the putting on the Art Fair.

2) The County Auditor's Office is currently auditing the Park Point Community Club financial records. One thing the auditor has said is that the Club can carry over \$4K-5K towards next year's fair, due to on-going and up-front costs.

3) LaFayette Youth Program is underway. Al noted this year's fees for attending have increased to \$400 for one child, \$300 for a second or third child. Fifteen to twenty youth enrolled up to now.

4) Tunnel passes are being sold for \$5.00, with the proceeds going to the Community Club and the Rowing Club. Report approved.

[Note: later in the meeting it was reported that sufficient tunnel passes have been sold to cover the cost of printing.]

Watch Committee - All of us

1) Officer Ethan Roe was introduced to us as the Duluth Transit Authority's new police officer. The purpose of this new position is to address issues that come up with bus ridership, the Transit Center and the Holiday Center. Officer Roe will ride buses, and track issues that come up. Currently, he feels it is safe to ride buses, but the impression some have is that it is not. He noted that he is a regular police officer, but is hired by the DTA, rather than the City of Duluth. 2) Officer Rowe gave Officer Lindberg's report. With summer here, there are more noisy cars, more parking issues and an increased volume of vehicles on Park Point. Regarding service calls, 37 were proactive (e.g., stopping cars) and 39 reactive (e.g., parking citations); generally, the goal is to have more proactive than reactive calls. Parks and Recreation is being asked for new signage at Lafayette, and Park Rangers have started patrolling. There was a question regarding a flatbed party wagon being out and about. Officer Roe said he has no information, but that it has not been licensed by the City.

Old Business

Pontliana Woods (area between Bayshore care facility and Harbor Point Circle) - Update by Gay Hooper Most of the City Councilors are on board supporting the development of this new city park. The area includes wetlands, and provides habitat for a variety of birds and animals. Please continue writing or calling city councilors and the mayor showing support for the development. Note: At the last county land auction, there were no bids on the southernmost parcel - the section upon which the County had not placed a sales moratorium, as it did with the northern parcel. This is the section between Harbor Point Circle and the apartments at 19th Street.

Signage at the "S" Curve: electronic sign is informative, rotating between information on rip currents, life guard location and beach fires. John Schmidt will follow up with Parks and Rec on the issue of lifeguards not being on duty when noted on the sign. As a member of the Parks and Recreation Commission, John acts as liaison, and will ask about toilet facilities at the Beach House, much needed for summer.

Photo Album: Tom Lyle would like to donate to the Community Club a photo album dating from Myrna Southworth's days. It has pictures with notations and is in need of repair. Resolution passed to accept the album. Club will pay for necessary repairs, and will also discuss how to make it available to a wider audience; e.g., library, historical society, etc.. Of note is that the Club also has other old papers that UMD students are currently examining and sorting.

Art Fair – June 27 & 28 - Jake Kapsner provided the update for Carla Tamburo.

Advertising has been done in a variety of venues including posters, radio and newspapers. Volunteers still needed; sign will go up at the "S-Curve" soon, with a general request to contact Diane Gould. A full slate of music and activities for fair attendees is planned. New this year is a tent showcasing emerging artists from area high schools and colleges. A survey is being done this year by faculty & students from UMD and the Twin Cities campus, in order to identify areas of success (or shortcomings), provide a portrait of attendees and their interests, and otherwise fulfill the requirements of the MN Arts Board Festival Grant. Jake asked that anyone who has photos to share after the fair please do so; they will be used for communication purposes and future promotion of the Art Fair.

Sunshine Committee - Pam Griggs

Four notes sent, including two expressing sympathy, one get well and one congratulatory retirement card.

Rummage Sale - If anyone has pictures of the rummage sale, please share them with Dawn, who will put them on the web site.

Environmental Report - Dick Gould

Eight wood ducks are nesting on Hearing Island; the eagles appear to be gone; three different types of ticks have been found this spring; there are no current signs of beaver activity; numbers of purple martens are down; the milk weed that was planted is coming up. There was a fire at 11th Street that went into the dune grass. Dick made note of boards that need replacement on the deck behind Lafayette. John Schmidt will communicate with Parks and Recreation on this issue. Nancy Olson – a piping plover has been seen at the end of the point, so please keep dogs (and your own feet) away from that area; she shared a picture with President Dawn.

Street End Issue

Pointers serving on the City Planning Department Study Group include Judy Dwyer, David Poulin, John Schmidt, Kinnan Stauber, Bob Swanson, and Chelly Townsend. Next week's meeting has been cancelled; tentatively, site visits will occur in early July. John Schmidt stated that none of the questions submitted by the Park Point Working Group have been responded to.

New Business

Neighborhood Night Out scheduled for August 4th, 5-7p.m. St. Andrew's by the Lake has offered to host and coordinate the event. Hamburgers, brats, and hot dogs, plus side dishes, desserts and beverages will be provided. Members of the Edible Garden Club will help St. Andrews with the event.

Duluth Superior Sailing Association: DSSA is asking for help with grass trimming, as well as the donation of a gas grill. Contact Tim Ingersoll (Waterfront Director of DSSA) at sailingforall@gmail.com if able to provide either. Information on sailing can be found at www.SailingForAll.org

Rowing Club: Tom Rauchenfeldt reported that the Rowing Club is still awaiting a DNR permit to begin building its new boat house; also, the property needs to be rezoned, but City Planning is supporting the zoning change. Ice this past winter damaged some of the supporting structure of the current boat house. As soon as the issues with the DNR are worked out, new building will begin.

Sale of "the store:" It has been reported that the store at 19th has been sold and will be torn down to replace it with a new store. No details of who the purchaser is, what kind of store, etc. are known.

Airport Update: Brian Madsen reported that the environmental assessment of the airport expansion is completed. The report is on the website. With the new plan, there is the possibility of three new hangers being built. The permitting and design process will begin soon. Construction is expected to begin in 2017. Love Creamery will begin selling ice cream outside the airport on week-ends this summer.

45th Annual Park Point Art Fair a Smashing Success!

As seems to happen by magic each June, a small caravan began its annual flow into the Park Point Recreation Area last Friday afternoon. Within hours, a tent village of painters, photographers, jewelers, glass-makers, pot throwers, and artists representing several other media was taking shape. 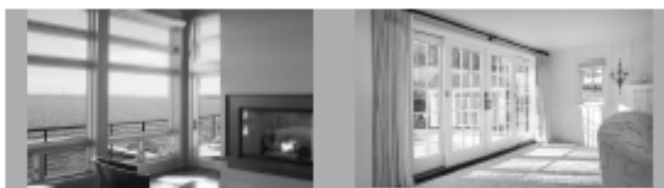

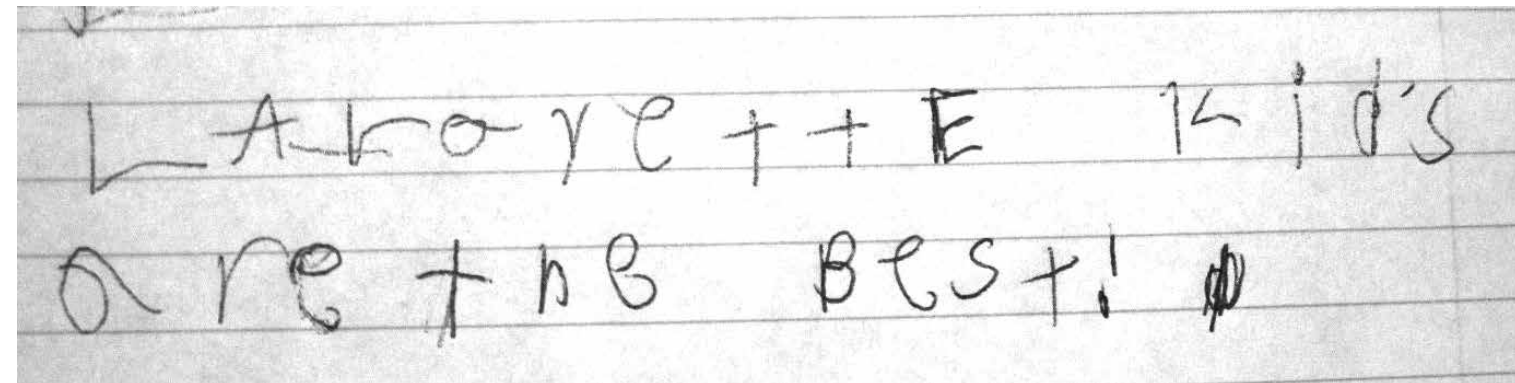

AN ORDINANCE

Changing the Names of Certain Streets on Park Point.

Passed Feb. 26, 1912; approved Feb. 28, 1912.

The Common Council of the City of Duluth do Ordain as follows:
Section 1. That the names of streets on Park Point are hereby changed as follows:

Marvin street to Eighth street south; Olive street to Ninth street south; Vine street to Tenth street south; Astor street to Eleventh street south; Dundee street to Twelfth street south; Argyle street to Thirteenth street south; Dunlieth street to Fourteenth street south; Cherry street to Fifteenth street south; Walnut street to Sixteenth street south; Sorenson street to Seventeenth street south; Spruce street to Eighteenth street south; Pine street to Nineteenth street south; Pearl street to Twentieth street south; St. John street to Twenty-first street south; Duke street to Twenty-second street south; Montana street to Twenty-third street south; Chambers street to Twenty-fourth street south; Church street to Twenty-fifth street south; State street to Twenty-sixth street south; New York street to Twenty-seventh street south; Randolph street to Twenty-eighth street south; Erie street to Twenty-ninth street south; Adams street to Thirtieth street south; Monroe street to Thirty-first street south; Murray street to Thirty-second street south; Clark street to Thirty-third street south; Warren street to Thirty-fourth street south; Williams street to Thirty-fifth street south; St. George street to Thirty-sixth street south; St. Cloud street to Thirty-seventh street south; St. Charles street to Thirty-eighth street south; Interlocken street to Fortieth street south; Warwick street to Forty-first street south; Pelenger street to Forty-second street south.

Section 2. This ordinance shall take effect and be in force from and after its passage and publication.

AN ORDINANCE

Changing the Name of St. Croix Avenue to South First Avenue East.

Passed July 1, 1913; approved July 2, 1913.

The City of Duluth does Ordain:

Section 1. That the name of St. Croix avenue be and hereby is changed to South First avenue east.

Pontliana Woods Park Plan Gathers Momentum

We start with some perhaps too-familiar background...

Harbor Point Circle divides two large tracts of state-owned land along the bay shore of Park Point. The smaller parcel, between Harbor Pt. Circle and the Bay Point Apartments, is referred to as Parcel 8 by the St. Louis County Land Department; north of Harbor Point Circle is the quiet refuge they call Parcel 9. We call it Pontliana Woods, which has a friendlier ring to it.

On May 5th, County Commissioners voted to place Parcel 8 up for auction, and to return Parcel 9 to the auction list in September if our efforts to protect it fall short. Moreover, the Commissioners directly tied any future price for Pontliana Woods to the results of the June auction of Parcel 8, No bidders met the minimum bid price, however, and Parcel 8 did not sell.

Certainly, this adds momentum as we push for lasting protection of Pontliana Woods. Team members are currently drafting language for a formal City Council Resolution to establish the woods as a City of Duluth park, zoned P-1. We've been receiving a constant stream of support from individuals and groups following our progress, and a majority of city councilors have voiced their support, as well. All this has done wonders for team morale, and we move ahead knowing we're working from a solid foundation here on the Point. Thank you all so much. We're gonna do this!

Summer Swimming's Finally Here!

Temperature readings 30 yards offshore are now routinely in the low 60's, for the hardy, so long as the wind comes from the east; 70's are not far off!

Remember:

Onshore (east) winds = warm temperatures, especially if we've had a few sunny days with little or no wind; offshore (west) winds = chilly water. Why? East winds scoop up the warm surface water, pushing it up against Park Point, whereas west winds take it away, mixing it in with the cold, less variable water, a few miles out.

Another way of putting it:

Hot days rarely bring the best swimming, because of prevailing west winds -

Sunny days in the 60's are often accompanied by water that is bathwater warm.

(But always beware of rip currents)



Letter to the Editor

In the wake of last month's rummage event, I feel a need to comment on this source of the annual big city-type traffic headache. I can understand why Park Point residents with items they would like to get rid of endure the inconvenience. However, what about the rest of us who do not fit that profile? Bluntly speaking, I must ask an obvious question: How does the Point as a whole benefit, if at all? It doesn't bring in money for the Community Club (unlike the Art Fair.) On the contrary, the Club spends \$500.00 a year to provide portable toilets and a small budget to advertise the sale.

Does anyone truly believe that all the used merchandise piled on the lawns are, in every case, the accumulation only of property owners? We, or at least I, find it hard to believe such big piles had accumulated for months prior to the public sale. If this were true, I would suggest the producers of the TV show about hoarding come here if in need of more examples of that addiction. Individual property owners, I learned, can charge a rental fee to anyone from any place to peddle their merchandise on private lawns. Whether that is in strict compliance with city ordinances, I do not know. My own opinion is that it certainly contributes substantially to unsightly clutter.

As for the massive traffic problem---as a retiree, I don't mind the need to drive at a very slow speed. I am fearful, however, that the frequent pedestrian inattention to the hazard of traffic could lead to personal injury accidents. One must always be ready to hit the brakes for those crossing the street, especially observant of children not closely supervised by adults.

Clearly, there are residents who do not favor the rummage sales concentrated in a two day time period. Defenders, on the other hand, note that this arrangement reduces the likelihood of seeing individual rummage sales spread out over many months. The Community Club, to its credit, has a committee that deals with the rummage issue. It welcomes input from Pointers, and you have the opportunity to express your position by attending Club meetings. Or by sending an e-mail to www.parkpointcommunityclub.org My own thought is that an overhaul would be wise, and changes made should be based on the input of the majority.

Switching now to a less contentious issue...nature: I have been disappointed with the low number of wildlife sightings this summer. Except for brief visits to my balcony from migrant warblers (they come to eat spiders and do a great job), I have had no luck in watching a heron or shorebirds feed along the water's edge. The beaver hasn't made itself known, nor has a mink or otter that used to swim by in past years. I miss them and will keep watching anyway.

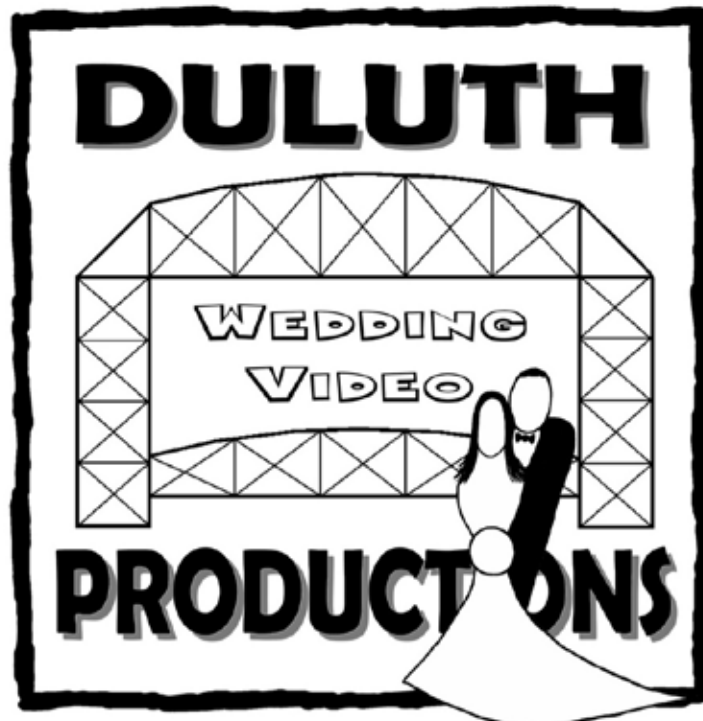
