### **President's Report**

Hi Neighbors,

It was exhilarating to get a whiff of spring wafting in from the south over the bay ice last week. I am so ready to blast out of this long winter of discontent and felt a bit of a pleasant lift at the Lafayette Edible Community Garden Crew zooming together on Feb. 8th. They were creating their list of hopeful 2021 yields and asking gardeners for their must haves and favorites. My trinity of favorites- basil, zucchini & tomatoes- aligns well with my skill set. Sadly, I did not inherit my Grandma Jean's knack for growing everything well. (You may recall my trauma from killing the beautiful orchid that she left for me in 2007.) The best news is that the Edible Garden Group is really more about celebrating collaboration and community; no green thumb or experience is required. The pine tree forest behind the Catholic church that's up for sale was mentioned at the February Club Zoom meeting. I found this in The Minnesota Point Timeline, page 48, by Jan E. Olson: Charlie McKeever, Bill Maynard and Father Michael Skumave planted pines from the middle of 19th Street to the middle of 20th Street; the forest was christened "Four M" for Mercy, Maynard, McKeever and Mike." I have extra copies of the Club's Timeline if you would like one; we might want to pick up documenting the Club's happenings at 1999 where Jan left off.

The Timeline provides a wealth of data points demonstrating Park Pointers' engagement and passion that are very well connected with today's issues at hand. The MN Point Timeline is a trove of activism and a testament that highlights the works of engaged citizens working for the betterment of the community. Issues of speeding and traffic safety, preservation of wetlands at Pontliana Woods, and erosion are just a few that have surfaced time and time again, many without resolution. I have been learning a lot on the topic of beach restoration and here are a few flashbacks on the erosion and high water front:

1995: Mayor Doty asks the USACE to investigate the erosion under Section 111 of the Rivers and Harbors Act, they said maybe a new study in 1996, in the meantime, dredge material placement is a possibility. The Club's president contacts the Dept. of Transportation about beach erosion and finds that the Corps accepts responsibility for beach erosion due to Duluth and Superior piers, "they won't do anything about it for several years although they offered beach nourishment"; club president asks for help in borrowing Jersey Barriers to use temporarily.

1994: Formation of Mayor Doty's Park Point Erosion Task Force, the City, DNR, and Club volunteers consider using Jersey barriers or wire mesh boxes filled with boulders used to manage erosion between 7th and 12th.

1985: Lake Superior levels were ten inches above normal. Club members write 200 letters and send them to government representatives. A Park Pointer crafts a letter in support of a bill in Congress that could include MN Point in the Coastal Barrier Resources System which would provide federal protection to the area from the airport to the Superior Entry.

1976: Three long time Park Pointer volunteers working on erosion concerns oppose the plan to place dredge materials from the bay into the lakeside beach; they want a more

permanent structure to stop erosion. MPCA District Director John Pegors urges agency director not to support transfer of dredge spoils into lake or onto beach because it is “environmentally incompatible, economically infeasible, navigationally unnecessary and potentially unhealthy.” (BTW, dredged spoils are classified as pollutants by state Pollution Control Agency law.)

1969: USACE studies erosion in hopes of combating the problem

1962: Residents from 12-25th don't want dredge spoils on the beach, bridge to 12th do. City Attorney rules disposal is ok.

1951: Power Squadron asks the USACE to investigate the “promiscuous dumping of garbage and other refuse” into the harbor, St. Louis River and lake, the Squadron files a complaint which includes photos.

Again and again, water and erosion concerns arise, solutions are sought and years of Park Pointers' own initiatives including dune grass, trees and shrubs plus boardwalks and fencing projects to protect the shorelines are documented.

Here we are now in 2021, still facing the same challenges with a new cast of characters, climate change dynamics, and the need for updated data from the USACE, whose last study of MN Point erosion from 2001 stalled out with no action towards a permanent solution. Why has this process taken so long and what might be different this time? The good news is that, in addition to engaged

and passionate Park Pointers, there are a number of organizations who are willing to align with the PPCC in seeking solutions to address this complex, under-resourced and unresolved set of problems. This fall and winter's discovery of sharp shredded cans, metal refuse and shards on the beaches on both ends of Minnesota Point has garnered the attention of citizens and groups interested in stopping the placement of dredged spoils in the lake and onto its beaches. (Minnesota Conservation Federation, Minnesota, Izaak Walton League, Save Lake Superior Association, Clean Water Action and others.) Their expert's calculations show that the 2019 & 2020 USACE beach restoration projects deposited levels of mercury into Lake Superior that have the potential to impact millions of fish. I believe we must pay close attention and continue to seek out all of the other options that are available. City leaders have taken actions to protect the shorelines of Canal Park and the Lakewalk. Continuing these efforts south onto the Minnesota Point beaches is a proposal hopefully moving up the priority list of our elected leaders; steadfast leadership will be required. Members of the PP Erosion and High Water Committee will continue to explore alternatives for protecting Minnesota Point favoring more permanent solutions. Future entries in the next volume of The Minnesota Timeline will tell the story of how the solutions evolved; working together on common goals will be essential.

Other important news, we are waiting on answers from the Parks and Recreation department on how Lafayette users will be required to pay for the utilities while using the community center. The Summer Youth Program is in a holding pattern and needs more parent volunteers to work on a 2021 program, please contact me if you are willing to help craft a budget and volunteer to support the camp's director and the campers during the program. Together, everyone achieves more.

The Traffic and Safety Initiative is moving along very nicely; thanks again for participating in the survey and your willingness to join the citizen's watch group. Thank you to Pat Sterner who is leading this effort ~ [patsterner20@gmail.com](mailto:patsterner20@gmail.com). Summer will be here before we know it and visitors will be headed across the bridge.

Thanks also to everyone who has been making an extra donation to the Club during the membership drive. We will stay afloat and our sails will fill.

## PARK POINT TRAFFIC SAFETY COMMUNITY SURVEY RESULTS

### 74 respondents

Question 1: In your opinion, which of the following sections experience the most traffic safety issues (excessive speeding, passing, tailgating, distracted driving)? (Respondents were asked to check all that applied)

Responses (Synopsis)

Between the S Curve and the Stop Sign at 19th Street 16.4%

· The Stop Sign at 19th Street and Lafayette Community Center 42.5%

Lafayette Community Center and The Rowing Club 37.0%

· From the Park Point Recreation Area (south end of MP to Franciscan at 39th 27.4%

· Other (please explain) 10.8%

o Bridge to the 10th ST turn to the hotels. FAST TURN LEFT

o Anywhere past the S-curve

o Really not sure. I'm most scared at the S curve, because that's where it gets the most cramped, but I hear people flying by my house near 32nd. The straightaway with no stop sign makes it so easy.

Question 2: In your opinion, where does speeding occur the most on Minnesota Point?

Synopsis:

Most responses noted that speeding occurs along any/all parts of the “Straightaway” usually starting at the Stop Sign at 19th Street to the end of the Point—and in both directions. One comment seemed to sum up all the comments: “The entire street is like a freeway”. Another comment was more poignant: “I’m only familiar with my immediate neighborhood and there are days I would move off the Point in a heartbeat and I’ve lived here for 77 years.”

There was identification of certain ‘zones’ along the aforementioned Straightaway, specifically:

· Stop Sign to Lafayette Community Center

· Lafayette Community Center to Franciscan/Rowing Club

· Franciscan/Rowing Club to the end of the Point

Question 3: What days and times of the week do you notice the highest number of traffic safety violations (excessive speeds, passing, tailgating, distracted driving)? Please mark all that apply.

Monday through Wednesday Between 5 and 9 pm

Thursday Starts at 2 pm, lasting until 9 pm and after

Friday, Saturday Between 2 pm and 9 pm; many noted after 9 pm (10 pm time when park closes)

Sunday and sunny days Between 2 and 9 pm, about equal.

Speeding between 10 am and 2 pm increases on Saturdays, Sundays, and sunny days.

Speeding and drag racing also occurs after 9 pm, lasting until well after 10 pm when the Park closes.

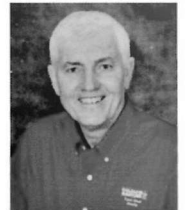

## News from the Lafayette Community Edible Garden

On February 8, 14 community garden households held a zoom get together. While not as much fun as our in-person potluck meetings, we enjoyed seeing each others' faces. Ellie and Coral took this opportunity to talk about our commitment to participating in the seed trials organized by the University of Minnesota Extension. The University supplied us with different varieties of seeds of the same plant and we supplied the space and manpower to grow them and document their progress. We analyzed them for success of growing in our garden and their taste. Last year we did trials for red leaf lettuce and basil varieties. We liked several of the varieties we tested so much we will be planting them in our gardens again in 2021. We hope to expand our seed trials and will form a committee to be in charge of that endeavor.

A special thanks goes out to several of our members and garden friends: LeAne Rutherford for her \$100 donation for manure, Dave Poulin for volunteering to mark the garden hoses so we have an easier time figuring out how to water the plants, and to Ellie and Coral for keeping our group on track.

When we have them, our monthly potluck dinners are FREE and open to all Park Pointers. They take place at the Lafayette Community Club....when it is open for use.

Here is a great savory bread that is quick and easy to whip up and is delicious with wintertime stews and soups.

**Susan's Savory Quick Bread:** This rustic bread, based on Australian damper bread, can be assembled, baked, and ready to eat in less than an hour. Flavor this bread to suit your taste: try replacing the Parmesan cheese and Italian seasonings with 3 tablespoons of dried dill weed or chili powder.

Yield: 1 loaf

4 cups self rising flour (check for freshness)  
1/2 cup instant nonfat dry milk  
1 cup Parmesan cheese  
1 tablespoon Italian seasonings  
1/4 teaspoon ground black pepper  
1 3/4 cups water, more or less  
1 tablespoon olive oil (optional)

Preheat your oven to 425°.

Oil a cast iron Dutch oven with a lid and heat it in the oven while the oven is preheating.

In a large bowl, mix together the flour, nonfat dry milk, Parmesan cheese, Italian seasonings, and black pepper. Add 1 3/4 cups of water and the oil. Using your hands or a wooden spoon, stir the ingredients until they come together into a dough, adding up to another 1/4 cup of water, if needed. Dump the dough on a floured surface and knead it a few times until it is soft and smooth. Form the dough into a disc about 8 inches in diameter and 1 1/2 inches thick. Slip it into the hot cast iron Dutch oven. Make 4 or 5 slices across the top of the dough with a sharp knife so the dough can easily expand as it rises and bakes.

Cover the Dutch oven, place it on the middle rack of your oven, and bake for 25 minutes. Reduce heat to 375°, remove the cover, and continue baking another 10 to 15 minutes, or until top is nicely browned, the bread sounds hollow when tapped, and the bread is 205° to 210°. Remove bread from the Dutch oven and let it rest on a rack for 10 minutes, if you can wait that long to cut into it.

## Environmental Report

The sighting of Wolves, Coyotes and Fox have been reported to me quite a bit this past month. It is their breeding season and I have seen many of them on both the lake and the bay. Be careful about letting your dogs and cats run loose as they are dangerous for them.

If you see anyone, including the City, cutting branches from pine trees off, or whole trees down, please call the DNR or me at 727-4067. This must be stopped. The club has spent thousands of dollars and many hours over the past forty years replanting and recreating the pine forest here on the point and it must be stopped!
