President's Report

Neighbor Jim Gruba recently sent me an interesting note about an item he found in the attic of a house at 2529 MN Ave. The home had belonged to Catherine Berg who died in 2011. Jim found a few old letters in the attic while taking the house down; one was an invitation to a lecture series in an envelope postmarked 1908. The officers of the Park Point Improvement Club were hosting and promoting a Wednesday evening lecture series- "Excellent series of free lectures on all subjects tending to elevate the standards of our community." Hhhmmmmm. Jim and I pondered the first presentation's content, "The Chloroformed Man" and the name of the person living at 2529 at that time from the envelope, "A. Wasfatt." I consulted Tony Dierckins of the Zenith City Press and we had our answers in just a few hours, thank you Tony! Tony's digging revealed that lecture number one's presenter was Reverend Roderick J. Mooney who was pastor of St. Luke's Episcopal Church in West Duluth. Tony sent us the Nov. 22, 1908 article from the DNT. "A. Wasfatt" was actually Andrew J. Wasgatt who worked as a clerk for the county auditor in 1908. In case you are curious, from the article, "Anything that will poison the mind will effectually chloroform the man- it matters not whether it is the licentious novel or the utterances of the irreligious person." Check the website for the whole article, some good stuff in there on elevating standards plus updates on where neighbors will be summering and wintering for 1908 and plans for a "thimble bee" at 3324. "Mr. and Mrs. Brust and family have taken the Brenton cottage at 2436 Mn Ave., for the winter season." If you have any interesting Park Point historical items to share, would you be willing to send them for sharing? Thank you! Please keep on shoveling those sidewalks, it's the neighborly thing to do. Thanks to all who help keep the walkways clear and the hydrants open.

Early this morning I stopped by the "new" restrooms at Lafayette and curiously came across a handwritten note. I managed to decipher the words without my glasses and it was very nice note of gratitude from a neighbor who walks the Point regularly and really appreciates the facility and its good care and condition. How kind to leave a note for the Parks and Rec. maintenance crew. I have a deep appreciation for a heartfelt thank you note; my mom stressed the importance and value of a timely, sincere and specific thank you card and she was right as usual :)

Yes, those bathrooms are wonderful and well used during all seasons. Kudos to neighbor Dennis Hoelscher for initiating the bathroom grant and the PPCC volunteers & City of Duluth staff who kept this project moving forward over the years until it became a reality. The bathrooms are up behind Lafayette and are open from 6am to 9pm daily. They are large enough for several kids, strollers, bikes and a giant canine friend or two.

Speaking of gratitude, the rink at Lafayette brought joy and provided a fun and safe place to "pandemic" together as a community. The group spent about 50 minutes reviewing successes and challenges in the past year and discussed both short and long term approaches to managing traffic safety going forward. PPCC President Dawn Buck, Pat Sterner and other PP residents expressed their appreciation for DPD's partnership in addressing traffic safety. Chief Mike Tusken thanked the PPCC for collaborating with DPD and taking an active role in our community to make it safer for everyone.

A special thank you was given to Lt.Chad Nagorski who worked closely with Pat Sterner and the PPCC over the past year; he will be taking on a new role in DPD and Lt. Dave Drozdowski will take over the coordination efforts between DPD and PPCC.

Efforts in 2021:

· Increased traffic safety work and patrols.

• Placed speed signs at 29th Street going south, and 32nd street going north.

· Placed Neighborhood Watch signs in two locations.

· Streamlined communications to DPD via the PP Clearinghouse site.

· Recording and reporting repeat offenders to DPD.

· Neighborhood Watch patrols active from April through October, made a difference calming traffic when out.

· Letters sent to PP and Canal Park Businesses promoting traffic safety efforts.

Ongoing issues:

• Truck traffic (revving engines, etc.): DPD did talk with them and are monitoring, but unless they observe the truckers speeding or passing they cannot cite them for noise.

• Speeding coming off the Aerial Bridge going south. This is still a big issue, along with parking on both sides of the street.

· Motorcycles speeding during summer evenings.

 \cdot Speeding and passing especially during the summer.

Ideas/Efforts for 2022:

 \cdot DPD has more resources and will allocate some for targeted traffic enforcement.

• Placement of flashing speed signs coming off the Bridge and coming out of the Park

• Place a decoy car in various locations on the Point (this was an idea for 2021 but not fulfilled for lack of resources; PP residents to help re: placement and storage).

• Contact all PP businesses via letter and visits. Ask Chief Tusken to co-sign the letter with PP President Dawn Buck. Ask the new Community Police Officer (Josh Newland) to go on visits with Pat Sterner.

 \cdot Covert speed study: PPCC provide DPD with several options on locations, dates, and times for a Covert Speed Study to be done on traffic on the Point.

· Contact the Coast Guard Commander to ask for their cooperation in controlling speed and noise. (Dave Drozdowski)

• Put up two more Neighborhood Watch signs on the Point. (Chad Nagorski has these)

· Continue to talk with neighbors and put information in the Breeze to promote traffic safety.

 \cdot Send an email notice/appeal to PP residents about traffic safety and increased patrols; include this information in every edition of the Breeze.

• Continue to encourage PP residents to send license plate numbers and other information about traffic offenders to the PP Traffic Safety clearinghouse (parkpointtrafficsafety@gmail.com) for further reporting to DPD.

• For repeat offenders, ask DPD to consider sending a registered letter informing the offender they have been recorded for chronic speeding/passing on the Point.

· Renew a call for Neighborhood Watch volunteers to help with traffic calming starting in the spring.

• PPCC coordinate with DPD when events are happening on the Point that will have increased traffic, parking, etc. (i.e., PP Art Fair, Rummage Sale, Rowing Club events, etc.).

Everyone acknowledged that speed signs, Neighborhood Watch, and increased DPD patrols help from a short term perspective, but unless a patrol car is on scene when an incident happens there is not much we can do other than record information and send on to DPD (which is still important to do).

There was an encouraging discussion about ideas for long-term solutions, which included working with City Engineering to help with more permanent resolutions to speeding on Park Point. Lt. Nagorski had been in discussions with City Engineering over the past year about several ideas; there has been staffing changes so Lt. Drozdowski will take over the discussions with the newly hired staff.

Engineering-based ideas included more stop signs (not popular), round-abouts or 'calming' (traffic) circles, and pedestrian crosswalks at Lafayette and the Duluth Rowing Club.

PPCC will work directly with Lt. Drozdowski and Sgt. Josh Newland going forward this year. Pat Sterner

MP 50 Minnesota Point Long-range Resiliency Planning

MP50 Informational Meeting, Feb. 7, 2022. Speakers were Diane Desotelle (City) and Nick Zager (USACE) talking about long term planning and Section 111 Study. Key takeaways:

- Diane Desotelle shared the City's 50 - year Minnesota Point planning process. This planning process

outlines how and when planning activities with the City and stakeholder groups are taking place.

- Diane Desotelle said the City is not requesting USACE beach nourishment this year.

- Section 111 has begun. Nick Zager outlined the USACE core process. The first meetings will be in March. - This MP50 meeting was recorded (www.youtube.com/watch?v=fbuMCZUyeb8)USACE

Section 111 Charrette is scheduled for March 10/11 Duluth, MN. 10 - 3. Hybrid in person/virtual 2 day meeting facilitated by USACE. Paul Treuer will attend and report to PPCC.

Goals:

1. Initiate the first iteration of the planning process for the study.

2. Begin building a coherent and effective project delivery team, including critical roles for both sponsors, stakeholders, and USACE colleagues.

3. Set expectations and establish a fresh, constructive approach to this study.

4. Provide a solid foundation for subsequent iterations of the planning process, scheduling of study milestones, and robust stakeholder engagement and public communication.

Planning Objectives:

- 1. Establish a planning process.
- 2. Define existing conditions, problems, opportunities, objectives, and constraints.
- 3. Generate possible management measures.
- 4. Develop an initial array of potential alternatives.
- 5. Introduce risk register.

Duluth Coastal Resilience Project

This Project is part of a \$258,000 FEMA grant the City of Duluth and St. Louis County to find solutions to shoreline collapse. The study will evaluate the bayside of the Park Point Recreation Area and determine mitigation options for storm surge-related flooding and erosion. Funding will pay for the areas of interest to be studied while determining solutions with the help of consultants. It will set the City and its partners up to apply for funding that would assist in implementing the study's outcomes.

The first Public Meeting of the Duluth Coastal Resilience Project was on Feb. 16, 7:00 PM. A recording is posted on the Duluth Coastal Resilience Project Webpage under Meetings: (<u>https://duluthcoastalinfrastructureresilience.com/</u> Minnesota Izaak Walton League Resolution (Jan. 30, 2022)

The State Chapter of the Izaak Walton League approved 7 resolutions about the disposal of dredge material for beach nourishment on Minnesota Point and its impact on Lake Superior.

First resolution: Oppose the disposal of dredge material from the Duluth-Superior Harbor for beach nourishment on Minnesota Point because it contains fines contaminated with legacy pollutants whose impact on Lake Superior are unknown, and because fine-grained river sediments erode off the beach too quickly.

Second resolution: Support beach nourishment to protect the residents of Minnesota Point if it is done with clean material such as sediment from Lake Superior or washed sediment from the Erie Pier Contained Disposal Facility (CDF); and if it is coarse enough to emulate natural longshore drift sediments that will stabilize and remain longer on the beach.


Infrastructure Funds for USACE and Erie Pier Fox News reported on Feb. 8, 2022 that \$19 Million in Federal Infrastructure Funding was awarded to the Port Authority of Duluth-Superior. \$13M going to USACE vessel yard on the Duluth Harbor Basin-Superior Bay side of Park Point. \$6 M goes to increasing capacity at the Erie Pier confined disposal facility (owned by Seaway Port Authority of Duluth & City of Duluth and operated by Detroit District USACE) to handle and transport dredging material.



Park Point Losses

Park Pointers have lost a number of special friends and contributors to the fabric of our community in recent months, among them PPCC Secretary/long-time supporter Sheryl Robbins, Capt. Tom Mackay and gentle giant Bill Ziemski, gardener and sailor extraordinaire. It's with great sadness that we learn of the death on February 11th of yet another master at the helm, Dr. J Clark Laundergan - or simply "J," as most knew him. Pointer Tom Rauschenfels recalls J as "very accomplished…thorough and safety conscious, (someone who) always wanted whomever he was with to enjoy the experience, whether rookie or expert. (He) never raised his voice or lost his cool…what is known as a 'Corinthian Sailor,' one who is always a gentleman when on a sailboat."

In addition to an extraordinary career as professor, mentor, researcher and academic writer, J enjoyed a reputation nationwide in the field of addiction treatment. His life's work toward the understanding of chemical and gambling addictions, in particular, earned him the respect not only of his colleagues here at UMD, but nationwide. In his later years, J added to his interests cutting edge research on the impact and too often tragic results of fraternity/athletic/social group hazing.

Where most Pointers came to appreciate J, however, was through his volunteer activities surrounding his Community Club and Art Fair interests, where he joined his wife and life partner Jean, who in the early 1980's served as PPAF director. I met both more than 20 years ago as a PP "newbie," when they recruited me to replace Maggie McGillis in that function. While I managed with their support to squeak by through two seasons, I quickly concluded that it was past time for us to professionalize that function to a greater degree; J joined me in setting up an 8-member search committee that resulted in the fortuitous selection of Carla Tamburro. Their gracious hospitality in offering their home for an hours-long interview process surely made that daunting experience at least somewhat less intimidating for its finalists. The couple have been longtime members of St. Andrew's Church by the Lake, where J's funeral will quite fittingly be held on the first day of this year's 50th Anniversary PPAF.

"I remember J and Jean as friendly, generous and kind," recalls PPCC President Dawn Buck, "...engaged with their community on multiple fronts." Indeed. Family have requested that any memorials be directed toward Alzheimer's research at http://act.alz.org/goto/laundergan
