President's Report

Great to visit with engaged neighbors and hear good questions at the presentation on the proposed flood maps last week! Thank you to City Planners Adam Fulton and Kyle Deming for showing us what the new FEMA maps look like and how to interpret them online. If you need help, call city planning for support. PPCC MP50 will collaborate with Planning Staff on the flood maps near the bridge based on the observations in Oct. 2019 which led to the Shelter in Place order- flooding occurred on both sides of the bridge. Areas down in the park on the south end on the bay side are at increased risk for flooding and the roadway will most likely be reconfigured, a study of the area is underway. The PPCC membership unanimously supported the 2023 Magic Smelt Parade which will be held this year on Sunday, May 28, a little later than in previous years. This is the Sunday of Memorial Day weekend and will again feature The Brass Messengers and the party at Zeitgeist Cafe. Meet at 330pm at the Aerial Bridge and wear silver. The parade workshops will start on May 13th at the Duluth Art Institute, Lincoln Park. The PP Summer Youth Program will host an Open House on Tuesday, April 18 from 5-7pm. This is just prior to the April PPCC meeting. Thank you to the PP parents who are working with the returning contractors on this year's program.

Birders, dog walkers, kayakers and adventurers who use the public land on19th, bay side, asked for assistance in finding the City office that would help with missing signage. Neighbors in the area contacted city staff to obtain the easement and the map of the public land inside of the gated and fenced area. There is a city dog waste dispenser back there and a kayak rack, not sure yet if that is one of the city's racks or not, stay tuned. I will post the map and the easement on the property so you can walk over and check it out and soon land or launch your kayak. Thanks to neighbor Pat Sterner of the neighborhood watch and traffic safety committee who is compiling a list of questions and concerns re. signage needs, parking concerns/strategies, dog issues on the beach, smelting, speeding, traffic calming, access points, emergency services when Canal Park is gridlocked and/or during summer events, garbage and recycling needs, porta potty needs at s curve, posting of hours of the bathroom facilities on the Point etc. Yes, that is a long list! Summer will soon be here and we must be prepared to welcome the thousands of guests who love Park Point. We are looking forward to getting together with city agencies/staff and Councilor Randorf to define problems, discuss possible solutions and see what can be done this spring for the upcoming, sure to be busy, and delightful summer! Thank you to everyone who keeps a close watch on what is happening in our community and for picking up the slack with trash and dog waste pick up when needed. Remember to call 911 if you see a crime in progress or even something that just does not seem right. If you see speeding, note the plate number if you can, and send to parkpointtrafficsafety@gmail.com. If you see reckless and dangerous driving, call 911 and tell the dispatcher what you are seeing then send Pat an email to the traffic safety email; she tracks repeat offenders and works with our community officer Ethan Roe.

We went to the Edible Garden potluck and the food was fabulous as it always is. The speaker for the meeting canceled and instead we went around the room and talked about who we were and our role/relationship with the garden and maybe what the garden means for each of us. We listened, we laughed, we remembered the history of the garden and how it came about in 2009, learned from one member how the concept of community gardens in Duluth was launched way back etc. A couple of themes emerged: how the garden and its rituals/needs have a "grounding" effect on members, how special and unique the garden is because it truly is a community garden~ all aspects are shared, the crop belongs to all and is shared with as many as possible.

Neighborhood Watch/Traffic Safety Report

Traffic Safety:

No updates as yet from City Engineering about possible ways to mitigate traffic issues. We will continue to engage with the City to work on these issues, including:

- \cdot Crosswalks
- · Diamonds painted in the 'Recreation Lane' during the summer
- · Additional signage
- · Increased patrols during high traffic times
- \cdot Letters and visits to Canal Park and Park Point businesses

Neighborhood Watch

We will be setting meetings within the next month with the appropriate City departments and our City Councilor to discuss possible solutions to the following issues:

Beach Safety: Dogs, Litter, Glass

Unsafe dog encounters on the beach are growing. Some residents report off-leash dogs acting aggressively to runners and creating concern for parents with young children. Requests for owners to leash dogs go unheeded; there are also increasing amounts of dog feces indicating that owners are not cleaning up after their pets.

May-October Parking

Parking on the Lake Side of the road during May – October impedes those using the rec lane and creates additional hazards. Current parking signage is not sufficient to inform non-Park Point visitors about the rules. Some suggestions made include putting up 'hand-made' signs at main beach access points to help inform the public, and asking the City to place a large sign about parking rules on the street-side fencing at the Lafayette Community Center to help visitors understand the rules.

Smelting Season

Many visitors during smelting season are respectful and we understand that the rules about fires and parking are somewhat suspended. However, residents have noted that it will be helpful to have additional signage for parking and also increased beach patrols to help manage the number of people who come to the Point to smelt.

Additional Signage

Two years running residents have placed requests to the City for signage replacement regarding bay access at 19th Street, as both signs showing public land have vanished. There used to be a water launch icon brown and white sign on the stop sign at 19th bayside and a Parks sign visible in/on the fence. Now the public land is blocked by a fence and gate. We will request again that the City replace the signs and ensure access.

Emergency Services

There are ongoing concerns about access to Fire, Police and EMT services when the Aerial Bridge is up, and what remedies might be put into place. The PPCC has and will continue to ask for the City's support in planning for emergency services for our locally planned events and local activities when Canal Park is surely clogged, as well as a Health/Safety Plan on Park Point when the beaches are packed and Canal Park is in a state of gridlock.

We are asking PP residents for ideas about how to address these particular issues. Please send your concerns and remedies to parkpointtrafficsafety@gmail.com.



News from the Lafayette Community Edible Garden

What a winter! As much as we might dislike the barrage of record-setting snow, we know we should be grateful for its benefits: it offers great insulation that protects plants' roots from being damaged from freeze and thaw cycles; it helps conserve soil moisture over the winter (as of mid-March there was 9" of water in Duluth's 34" snowpack); and it provides a boost of nitrogen to gently fertilize the garden. However, it inconveniences our lives by forcing us to shovel the stuff when we have better things to do, and it makes us rearrange our schedules. That's what happened in March, when our planned potluck dinner on the 13th had to get pushed back a week because of the snow accumulation.

We moved forward on March 20 with our potluck dinner meeting without our planned Tom Kasper. Instead, participants shared their own stories so everyone got to know each other better. The general consensus was that our community garden is a special place and everyone liked being part of its community. We also discussed the Duluth Community Garden Program's Vegetable of the Year: collards. We decided that we wanted our own vegetable of the year and voted to plant unusual potatoes in the oval bed usually designated for the vegetable of the year. We will honor the DCGP's choice of collards by planting a small bed of them in another area of the garden.

Our monthly potluck dinners are FREE and open to all Park Pointers. They take place at the Lafayette Community Club. Please bring your own plates, silverware, beverage and a dish to share. We will continue to have out monthly potluck dinner meetings on the second Monday of the month from 6 to 8 p.m.

At the March potluck dinner, Erin O'Hearn brought a delicious vegan chili that everyone raved about. Erin reports that she got the recipe from Park Pointer Erin L'Allier, who was happy to share it with us.

Chipotle Chili with Sweet Potatoes

- 2 Tablespoons olive oil
- 1 medium onion, diced
- 1 poblano or Anaheim pepper, diced (or jalapeno pepper, if you like more heat)
- 4 garlic cloves, minced
- 1 Tablespoon chili powder
- 2 teaspoons ground cumin
- 1/2 teaspoon chipotle chili powder, or more to taste
- Pinch ground cloves
- 2 teaspoons sea salt.

Ground black pepper, to taste

- 1 (14-15oz) can diced tomatoes in juice
- 1 (14-15oz) can kidney beans, drained and rinsed
- 1 (14-15oz) can pinto beans, drained and rinsed
- 1 (14-15oz) can black beans, drained and rinsed
- 1 pound sweet potatoes, peeled and shredded (about 4 cups)

Garnishes: diced avocado, tortilla chips, fresh cilantro

Sauté onion, pepper and garlic in the olive oil about 6 minutes to soften. Add spices, salt and pepper to taste and stir until fragrant, about 1 minute.

Add tomatoes and their juice and cook for another minute or two.

Add beans, sweet potatoes and 2 1/2 cups water. Bring to a boil, lower heat to a simmer and cover. Cook until sweet

potatoes are tender and the chili is thick, at least 1 hour.

Adjust seasons and serve with desired toppings.-

Strengthening Coastal Communities Resilience in the Great Lakes Region Challenge: Minnesota Point

- Mn Point has been selected as one of four coastal communities by the Association of State Floodplain Managers (ASFPM) to receive a year of training and technical assistance to assess flood vulnerability and develop plans and policies that emphasize natural and nature-based solutions. Our team is led by Julie McDonnell, Mn DNR and consists of other members including City of Duluth, Duluth Planning Commission, UMD, and MP50. It has recently been by Fond du Lac members and the DNR hydrologist.

- The Minnesota Point Duluth Team met with the ASFPM team via GoogleMeet on March 21, 2023 to kick off the year-long Technical Assistance Process. In preparation for this meeting the Duluth Team has assembled community planning documents that govern land use and development on Minnesota Point.

- Today we started the first (of three) phases of the technical assistance program: Self-Assessment

- Reviewed the process for selecting 4-5 community planning documents to analyze and determine how well they are integrated to address disaster vulnerability.

- Began the process of doing a Coastal Resilience Self-Assessment. Led through the process by David Hart, Wisc. SeaGrant. He used the Coastal Resilience Self-Assessment tool to lead our team to identify coastal hazard risks of Mn. Point. We will proceed to identify and assess practices in place to mitigate impacts of coastal hazards and then proceed to identify possible practices. These results will help us get a pulse on coastal hazards on Mn. Point and opening up conversations with Mn. Point stakeholder groups on the severity of those hazards and what can be done about them.

- Personally: program staff are knowledgeable and experienced; the Mn Point participants have experience with planning and are well working together.

- Materials are lengthy and will be shared with PPCC through email and MP50 meetings.

MP50 Meeting

- The next MP50 Zoom meeting will be Thursday, April 6 from 9:30 - 11:00 AM CDT. There will be presentations from USACE on Section 111 Updates and from the Duluth ASFPM Group on Mn Point Coastal Communities Resilience Planning.

Outreach

- MP50 will make a presentation on Erosion and Flooding of Minnesota Point to students from UWisc Eau Claire Geomorphology class on April 21/22 at Lafayette.

FEMA Flood Map Update for Minnesota Point

- Duluth City planners, Adam Fulton and Kyle Demming presented information about the updated FEMA flood maps at the PPCC March 21 meeting. Adam Fulton is Deputy Director of City of Duluth Planning & Economic Development and is a member of the Mn. Point ASFPM Team. Duluth city maps have been updated with the proposed flood maps and are publicly available for viewing at: https://duluthmn.gov/planning-development/environmental/natural-resources/.
