Going from pumpkin spice to pumpkin pie!

Minnesota Point 50-Year Resiliency Initiative (MP50)

Vision: Minnesota Point, a dynamic and fragile ecosystem and community, sustains its land, water, wildlife, infrastructure, and people for generations to come.

Mission: We lead strategic actions with a diverse group of partners to ensure the ecological, cultural, and economic resilience of Minnesota Point.



Section 111 Study. The City of Duluth and US Army Corps of Engineers hosted the second public meeting on the Minnesota Point Section 111 Study. The event was held October 29th in the Lecture Hall in the Maritime Museum Visitor Center, 600 Canal Park Drive from 2:00 - 4:00 PM. Jim Filby Williams, City of Duluth Director of Property, Parks, and Libraries, made introductory comments. He was followed by the USACE Section 111 Team Lead, Bridget Rohn, who provided updates on the schedule, budget, and scope of the Study. Barr-Bergmann engineers presented a summary of progress to date on the modeling study. This public meeting was recorded. Links to the recording and presentation materials are available at the MP50 website. A special thanks to the City for hosting this opportunity for the public to learn about the modeling study and to ask questions about the study while it is being done.

Community Climate Implementation Fund. The City of Duluth, Minnesota DNR Lake Superior Coastal Program and MP50 submitted an application to the Urban Sustainability Directors Network, Climate Mayors, for a grant to convene and co-host a coastal resilience partners summit in 2025, the purpose of which will be the review and update the Coastal Resilience Action Plan for Minnesota Point. Duluth Mayor Reinert wrote a letter of support for the application stating, in part, that "Minnesota Point's unique ecological, economic, and social value makes it imperative that we move beyond short-term interventions to a comprehensive and inclusive resilience strategy." Collaborating with Minnesota Point partners on the Coastal Resilience Action Plan is a strategy we hope will start in 2025 and become an annual event.

Sky Harbor Airport Terminal to be Named for Dr. Robert R. Gilruth, NASA Aerospace Pioneer

The Duluth Airport Authority is pleased to announce the Sky Harbor Airport's new terminal will be named after Dr. Robert R. Gilruth, a legendary aerospace engineer and NASA's first director of the Manned Spacecraft Center. A dedication ceremony was held at Sky Harbor Airport on Thursday, October 24, 2024, at 2:00pm "Dr. Gilruth was a remarkable engineer who made significant contributions to flight research and space exploration," said Tom Werner, Executive Director of the Duluth Airport Authority. "We are proud to celebrate his northern Minnesota heritage and enduring legacy with the naming of the Dr. Robert R. Gilruth Terminal." Gilruth was born in Nashwauk, Minnesota, and moved to Duluth as a child. He graduated from Duluth Central High School in 1931. Gilruth then attended the University of Minnesota, earning a Bachelor of Science in Aeronautical Engineering in 1935 and a Master of Science in 1936. After graduating, Gilruth worked at NASA's Langley Memorial Aeronautical Laboratory. Throughout his 40-year career with NASA, Gilruth held many leadership positions and was instrumental in driving the Space Race. As Director of NASA's Space Task Group, Gilruth and his team worked tirelessly to understand and execute a strategy for manned space missions. Gilruth served as director of NASA's Manned Space Group for ten years, overseeing 25 human space flights during the Mercury, Gemini, and Apollo programs. The Robert R. Gilruth Terminal at Sky Harbor Airport opened on July 10, 2024, representing a \$2.66M investment in aviation in northeast Minnesota. The terminal meets all floodplain requirements and ADA compliances. New amenities include an upscale pilot lounge, a modern flight planning room with up-to- date aeronautical information, vending options, and outdoor patio areas, which will be open to the public.

Sky Harbor Airport was created for pilots and travelers with a passion for a simpler approach to flight. Our unique amphibious air base accommodates both land and seaplane traffic and has the beautiful city of Duluth and the splendor of Lake Superior as backdrops to an experience that is unlike any other. The airport has an average of 13,500 flight operations per year. 



News from the Lafayette Community Edible Garden

Have you noticed the nice newly repaired garden beds? Keith McLaughlin and his hardworking team finished those recently. We are grateful for Keith and Deb's vision and expertise and all the folks who helped them. Ellie also expressed gratitude to Coral and Brooks for keeping a watchful eye on our garden from their next-door perch. And, Missy was thanked for her efforts to keep everyone informed about garden activities in her weekly email blast called The Dirt.

Even though we are experiencing drought condition, the garden watering angels ensured there would be food to harvest. In October, we picked winter squash, garlic, beets, leeks, tomatoes, yellow and pole beans, peppers and kale. October is also the month when we start planting for next year's crop. Garlic was planted in a number of beds and rye was planted as a cover crop in many of the beds.

Our October 14th potluck dinner meeting started off with a land acknowledgment as a tribute to Indigenous People's Day – by Missy King. She included a brief history of the Ojibwe people and their language. Then, Ellie Alspach reviewed the successes and failures of the 2024 garden plantings and explained how and why we plant the plants we do in the garden. Attendees filled out questionnaires to help guide the 2025 garden plans. The mysterious big orange pumpkins grown in the compost bed were raffled off to those interested in carving them or cooking them.

On November 11, we will gather for another potluck dinner and to learn about the history and lore of the Southworth Marsh on Park Point. Kinnan Stauber (Ellie Alspach's daughter) has delved into that history and she will share her knowledge with us through a slide presentation.

Compost Update: Coral says, "Thanks for bringing your kitchen scraps to the garden compost. However, please dump the scraps into the compost and put the bags in trash. Even the ones that say they are compostable don't work in our compost bin, as it doesn't get hot enough to break down that material like the compost facilities at WLSSD do."


